



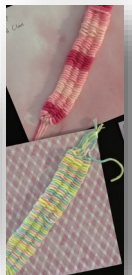
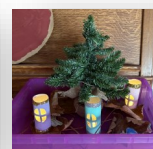
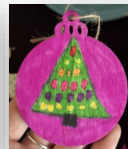
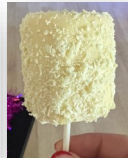
In A Nutshell

Dear All

It is that time of year again when we gear up for the Winter Fair! Today we celebrated the children's oracy using persuasive language to convince our Dragon's Den panellists to invest in their product! Celebrating women in business, we were honoured that our Co-Chairs and Deputy Governors were part of the panel as well as Mrs Griffiths, founder of Pup Rock Pets Accessories. The competition has definitely been upped as it was a hard choice. I am pleased to announce the winners are **Year 4**! Next week, the children will be busy making their products to sell at the Winter Fair after school! The Winter Fair starts at 3.15pm so that the teachers have time to dismiss their classes and get to their stalls. We are excited that Warlingham Choir will be entertaining families outside the small dining hall whilst you wait! Please can we request that buggies are parked under the bike shelters so that there is more space to manoeuvre around the building. We also have our fingers crossed the weather forecast improves!!



This week, Year 5 on one of the dry, sunnier days, have been working on developing their scientific skills, learning how to plan a fair test. They designed an experiment to show the effects of air resistance and evaluated their findings.



In Year 2, the children have been learning about 2D shapes. They have been using our new resources (purchased with money raised from the Autumn disco) to make regular and irregular 2D shapes. We have had a big focus on children using the correct mathematical vocabulary, such as sides and vertices so well done Year 2, you are amazing mathematicians!



Finally, Year 4 took a trip back to the Roman times, practicing Roman soldier drills, trying olives, honey and poppy seed cakes and they made mosaics!

Well done to the Year 2's who competed in their first football tournament yesterday! Their team work was great and demonstrated some fantastic skills.

This week we explored our half termly book for Little Wandle - 'All through the night'. The children had discussions about what they might see in the sky at night as well as what jobs people might do during the night. Some children shared photos of themselves looking at the night sky on Tapestry so we could look at these photos during our discussion time.

Through a variety of creative activities, we explored the book. Some children made their own messy footprints, based on the book character Sammy who was a cleaner, so that others could sweep the footprints away.

Through our discussions around different night worker jobs, the children shared what night jobs their family members do. We also used picture cards and small world resources to support this theme.

We transformed our home corner into a bakery and throughout the week, the children have eagerly used the bakery, taking on different roles such as baker, cleaner, health inspector and shelf stacker.

We have explored numbers and simple addition in simple purchasing themed activities. During the week, the children have had a chance to bake either bread rolls, gingerbread men or crispy cakes. They also helped to make our nursery Enterprise prototype items to sell at this year's Winter Fair.

We have also explored The Starry Night picture by Van Gogh. We discussed the colour of the sky and what we could see in the picture. The children then recreated their own starry night pictures.

Collection of Hamsey Green children by older siblings

Please be reminded that children can only be collected by someone over the age **16**; unless we have been given written permission from a parent for those in Years 5 and 6 to leave without an adult.

After school activities

If your child is not going to be attending an after school activity but has been in school that day, please can you **inform the office** and not the class teacher. The office maintains the registers for all clubs and needs to be aware of any child who is not going to be in attendance. Thank you for your co-operation.



Children should **NOT** be riding their scooters or bikes through the staff car park, down the driveway or through the playground at the beginning or end of the school day. Please ask the children to dismount and ensure you supervise your children whilst they are on them. Adults have reported some children are riding on the school grounds that is likely to cause an accident or damage to cars. Thank you for your co-operation.

PARKING & ROAD SAFETY

Once again, we have had some phonecalls from neighbouring properties regarding inconsiderate parking and unacceptable behaviour/language towards our neighbours at drop off and pick up times. **Please park considerately around the neighbouring properties to the school. According to the Highway Code it is an offence to park across driveways and it is illegal to park over dropped kerbs. Parking on a private driveway without consent is a civil offence of trespass and may result in prosecution. This is applicable even if you have put your hazard lights on.** A number of parents have raised concerns regarding speeding traffic on Tithepit Shaw Lane at drop off and collection times. Please complete the road safety assessment form for Surrey to assess the road. [Select the option most like the issue - Report a highway issue - Surrey County Council \(surreycc.gov.uk\)](#) - please select Road Safety Outside a School. Should anyone be interested, there is a vacancy for Road Crossing Patrol for outside the school. This is a paid vacancy through Surrey County Council.



Absences, medical appointments & sickness

If your child is absent from school or has a medical appointment, please email absence@hamseytlt.co.uk or leave a message on the absence line (01883 622000 option 1). Please let us know their full name, class and reason; including any symptoms they may be displaying. We do need to hear from an adult **each day** a child is absent for safeguarding reasons. Please do not bring your child to school if they have been sick during the night. If your child has been sick or has an upset stomach, children may be off school for 48 hours following the last episode, each case is dealt with separately.

To avoid impacting your child's attendance ALL medical/dental/optician appointments should be booked outside of school hours

If you consider that there are exceptional circumstances relating to your request, please let the school have full details. Each application for a leave of absence will be considered on a case by case basis.

Penalty Notices to Address Poor Attendance at School

A Penalty Notice may be issued as an alternative to the prosecution of a parent/carer for their child's unauthorised absence from school (absence without the agreement of the school or not covered by a medical note) and will be used by Surrey County Council in the following circumstances :-

1. Pupils identified by police and Attendance Advice Officers (formerly Education Welfare Officers) engaged on Truancy Patrols and who have incurred unauthorised absences.
2. Leave of absence in term time (5 days or 10 sessions or more).

Please be aware that The Education (Pupil Registration)(England)(Amendment) Regulations 2013, which became law on 01 September 2013 state that Headteachers may not grant any leave of absence during term time unless there are exceptional circumstances.

The Headteacher is also required to determine the number of school days a child can be away from school if leave is granted.

In such cases the Headteacher/Governing Body must decide whether there are exceptional circumstances. They may request that Surrey County Council issue Penalty Notices when the absence is not authorised.

Warnings will not be given where it can be shown that parents have been notified that such absences will not be authorised.

3. Finally, the issuing of a Penalty Notice will also be considered where it is judged that a parent is failing to ensure their child's regular school attendance.

This will be considered when a pupil has incurred 10 or more unauthorised sessions in the previous 10 school weeks, which may include a pupil arriving late after close of registration.

If you believe at any stage that your child's absence from school may leave you liable to receive a Penalty Notice, it is extremely important that you act without delay to secure their regular attendance.

If you have any questions or require further support to achieve an improvement in your child's attendance, please contact your child's school or the Attendance Advice Officer.

Penalty Notice relating to Exclusions

If a child is excluded from school, Section 103 of the Education and Inspections Act 2006 places a duty on parents/carers to ensure that their child is not in a public place without justifiable cause during school hours.

This duty applies to the **first five days of each exclusion**. Failure to do so will render the parent/carer liable to a Penalty Notice. (Alternative education provision will be made available from the sixth day of any exclusion.)

Amount Payable for a Penalty Notice and Consequences for repeat unauthorised absences

1. If you have not incurred a penalty notice relating to this child/children [in a rolling 3 year period](#) since 19 August 2024, then the penalty notice will be charged at the rate of £160.00, **per parent/carer per child**, if paid within 28 days. This will be reduced to £80.00 if paid within 21 days of receipt of the notice. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.
2. If you have incurred a penalty notice relating to this child/children since 19 August 2024, the rolling 3 year period will be activated from the date of the first penalty notice and the second penalty notice will be charged at the flat rate of £160.00, **per parent/carer per child**, if paid within 28 days. There will be no reduction for payment within 21 days. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.
3. If you have incurred 2 penalty notices relating to this child/children in the rolling 3 year period since the first penalty notice was issued, then you will NOT receive a third penalty notice – Surrey County Council will have no option but to consider a prosecution, **per parent/carer per child**, in the Magistrates Court under s 444 Education Act 1996.

Surrey County Council is not responsible for authorising pupil absence and therefore cannot withdraw any Penalty Notice requests without the written permission of the Headteacher.
