Dear All

Having been away with Year 6 on their residential this week, time seems to have flown by! The children have been exposed to new experiences and have tested skills such as resilience, teamwork and thinking outside the box; as well as getting them out of their comfort zone. Comfort was definitely amusing- seeing them in their bunk beds in the yurts! We were so lucky with the weather! In groups, they experienced archery- with one scoring a bullseye on their first aim, rock climbing and bouldering, navigating across a low ropes challenge course, operating a canal boat through a lock (as well as chilling on the canal boat sipping hot chocolate!!), canoeing and a definite favourite activity, paddle boarding. As I wasn't allowed to kneel or stand on a paddle board, I was reluctant to miss out so I was paddled down the river on the large paddle board, as the children took turns to oar! In the evenings, the children continued learning about the WW2 Home Guards and Air Raid Wardens. They were very excited to be in a real Air Raid Shelter, question their friends to see if they were friend or foe as well as pump old fashioned water pumps to put out a real fire (pretending to be in The Blitz (which may or may not have resulted in a water fight...what stays on camp...!)) The children were mainly asleep by just after midnight and up again at 6.30am which is unheard of usually. Year 5 look out for information to register your interest for next year - it will come around very quickly!

I was also extremely proud to hear that Butterworth and Inkpen managed to navigate eating in the big hall for the first time too, learning how to carry their plates from the hatch, collecting their salad and puddings, without any spilt dinners. Well done!

Although the temperature was rising, it was lovely to return to see Year 4 in their class assembly this morning and I am sure Year 5 are excited to present theirs this afternoon. I am sure we will melt in the hall at nearly 30 degrees predicted! Please remember that sun hats need to be in school daily and sun cream applied as it will be very hot again over the next few weeks.

This week in Nursery, we continued our theme of Holidays, exploring different types of transport that people use when going on holiday. The children enjoyed discussing their own travel experiences and learning about journeys by car, train, aeroplane and boat.

As part of our football focus and in anticipation of the 2026 World Cup, the children came to Nursery dressed in their football kits to support England and their home countries. It was wonderful to see such enthusiasm and pride as the children shared who they were supporting and talked about their favourite teams.

The children took part in a variety of football activities, beginning with warming up their muscles and discussing how exercise affects our bodies, particularly how our hearts beat faster when we are active. They practised goal shooting, took turns being the goalkeeper; and worked together passing the ball in pairs before progressing to passing in groups of four. The children also developed their dribbling skills by weaving around cones and practised stopping the ball using their feet.

Alongside our physical activities, we explored the numbers on football shirts and made score predictions for the match. We also talked about female footballers and discussed the achievements of the Lionesses, helping the children understand that football is a sport enjoyed and played successfully by everyone.

The children also enjoyed getting creative by designing a football caricature using their own photo, which will be displayed on our football match themed wall display.

To celebrate Father's Day, the children created special cards. They were very proud of their creations and enjoyed talking about what they know and love about their dad or special person in their life.

In our daily phonic sessions, we have focused on the 'sh' sound.

Staying safe around water this summer

As the weather warms up, more young people are spending time outdoors and around open water. Surrey Fire and Rescue Service is reminding families to stay safe around water this summer.

We ask parents and carers to have an open conversation at home about staying safe near rivers, lakes, reservoirs and quarries. While these places may look calm and inviting, they can be extremely dangerous. Cold water shock, hidden hazards, sudden drops and unstable ground can all pose serious risks, even for strong swimmers.

Figures show that between 2019 and 2024, 1,602 people in the UK lost their lives in accidental drowning incidents. 56% (901) of these occurred in inland waters such as rivers, lakes and reservoirs. Alarmingly, around half of those who drown had no intention of entering the water, with slips, trips and falls identified as a leading cause.

We are also seeing an increase in risk-taking behaviour, including swimming in unsupervised areas, jumping into unknown water and accessing restricted locations. These situations can escalate quickly and may be difficult for emergency services to reach.

It's important that young people know what to do if they find themselves in trouble in the water. Teach your child to Float to Live: tilt their head back with ears submerged, relax and try to control their breathing, use their hands and legs to stay afloat, and once the effects of cold water shock have passed, call for help or swim to safety if able.

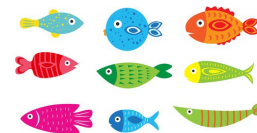
Please also remind your child that if they ever see someone in trouble in the water, they should call **999** immediately and never attempt a rescue themselves.

Please encourage your child to stay out of unsafe water, follow warning signs and look out for their friends. By talking about the risks and how to respond, we can help keep young people safe around water this summer.

Maintaining high attendance


At primary school, children who have high attendance (95-100% attendance) in Year 6 are 30% more likely to achieve the expected standard in reading, writing and maths compared to similar pupils who miss just 2-4 weeks of school (90-95% attendance).

Collection of Hamsey Green children by older siblings

Please be reminded that children can only be collected by someone over the age **16**; unless we have been given written permission from a parent for those in Years 5 and 6 to leave without an adult.

After school activities

If your child is not going to be attending an after school activity but has been in school that day, please can you **inform the office** and not the class teacher. The office maintains the registers for all clubs and needs to be aware of any child who is not going to be in attendance. Thank you for your co-operation.



Children should **NOT** be riding their scooters or bikes through the staff car park, down the driveway or through the playground at the beginning or end of the school day. Please ask the children to dismount and ensure you supervise your children whilst they are on them. Adults have reported some children are riding on the school grounds that is likely to cause an accident or damage to cars. Thank you for your co-operation.

PARKING & ROAD SAFETY

Once again, we have had some phonecalls from neighbouring properties regarding inconsiderate parking and unacceptable behaviour/language towards our neighbours at drop off and pick up times. **Please park considerately around the neighbouring properties to the school. According to the Highway Code it is an offence to park across driveways and it is illegal to park over dropped kerbs. Parking on a private driveway without consent is a civil offence of trespass and may result in prosecution. This is applicable even if you have put your hazard lights on.** A number of parents have raised concerns regarding speeding traffic on Tithepit Shaw Lane at drop off and collection times. Please complete the road safety assessment form for Surrey to assess the road. [Select the option most like the issue - Report a highway issue - Surrey County Council \(surreycc.gov.uk\)](#) - please select Road Safety Outside a School. Should anyone be interested, there is a vacancy for Road Crossing Patrol for outside the school. This is a paid vacancy through Surrey County Council.



Absences, medical appointments & sickness

If your child is absent from school or has a medical appointment, please email absence@hamseytlt.co.uk or leave a message on the absence line (01883 622000 option 1). Please let us know their full name, class and reason; including any symptoms they may be displaying. We do need to hear from an adult **each day** a child is absent for safeguarding reasons. Please do not bring your child to school if they have been sick during the night. If your child has been sick or has an upset stomach, children may be off school for 48 hours following the last episode, each case is dealt with separately.

To avoid impacting your child's attendance ALL medical/dental/optician appointments should be booked outside of school hours

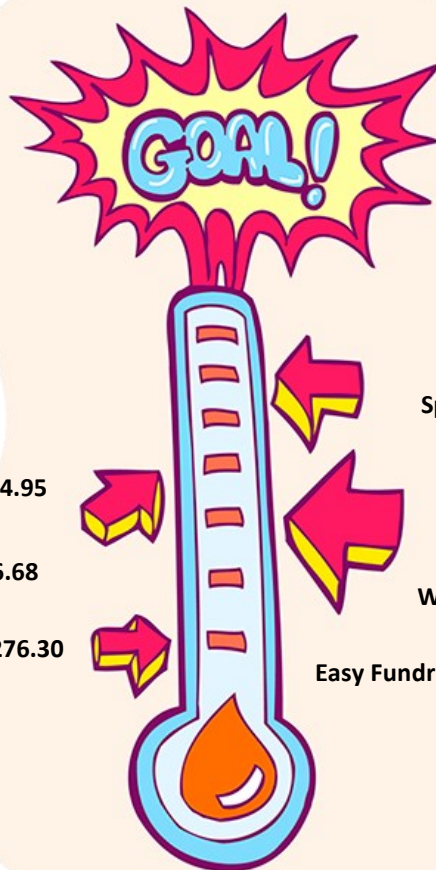

If you consider that there are exceptional circumstances relating to your request, please let the school have full details. Each application for a leave of absence will be considered on a case by case basis.

Penalty Notices to Address Poor Attendance at School

A Penalty Notice may be issued as an alternative to the prosecution of a parent/carer for their child's unauthorised absence from school (absence without the agreement of the school or not covered by a medical note) and will be used by Surrey County Council in the following circumstances :-

1. Pupils identified by police and Attendance Advice Officers (formerly Education Welfare Officers) engaged on Truancy Patrols and who have incurred unauthorised absences.

2. Leave of absence in term time (5 days or 10 sessions or more).

Please be aware that The Education (Pupil Registration)(England)(Amendment) Regulations 2013, which became law on 01 September 2013 state that Headteachers may not grant any leave of absence during term time unless there are exceptional circumstances.

The Headteacher is also required to determine the number of school days a child can be away from school if leave is granted.

In such cases the Headteacher/Governing Body must decide whether there are exceptional circumstances. They may request that Surrey County Council issue Penalty Notices when the absence is not authorised.

Warnings will not be given where it can be shown that parents have been notified that such absences will not be authorised.

3. Finally, the issuing of a Penalty Notice will also be considered where it is judged that a parent is failing to ensure their child's regular school attendance.

This will be considered when a pupil has incurred 10 or more unauthorised sessions in the previous 10 school weeks, which may include a pupil arriving late after close of registration.

If you believe at any stage that your child's absence from school may leave you liable to receive a Penalty Notice, it is extremely important that you act without delay to secure their regular attendance.

If you have any questions or require further support to achieve an improvement in your child's attendance, please contact your child's school or the Attendance Advice Officer.

Penalty Notice relating to Exclusions

If a child is excluded from school, Section 103 of the Education and Inspections Act 2006 places a duty on parents/carers to ensure that their child is not in a public place without justifiable cause during school hours.

This duty applies to the **first five days of each exclusion**. Failure to do so will render the parent/carer liable to a Penalty Notice. (Alternative education provision will be made available from the sixth day of any exclusion.)

Amount Payable for a Penalty Notice and Consequences for repeat unauthorised absences

1. If you have not incurred a penalty notice relating to this child/children [in a rolling 3 year period](#) since 19 August 2024, then the penalty notice will be charged at the rate of £160.00, **per parent/carer per child**, if paid within 28 days. This will be reduced to £80.00 if paid within 21 days of receipt of the notice. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.

2. If you have incurred a penalty notice relating to this child/children since 19 August 2024, the rolling 3 year period will be activated from the date of the first penalty notice and the second penalty notice will be charged at the flat rate of £160.00, **per parent/carer per child**, if paid within 28 days. There will be no reduction for payment within 21 days. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.

3. If you have incurred 2 penalty notices relating to this child/children in the rolling 3 year period since the first penalty notice was issued, then you will NOT receive a third penalty notice – Surrey County Council will have no option but to consider a prosecution, **per parent/carer per child**, in the Magistrates Court under s 444 Education Act 1996.

Surrey County Council is not responsible for authorising pupil absence and therefore cannot withdraw any Penalty Notice requests without the written permission of the Headteacher.
